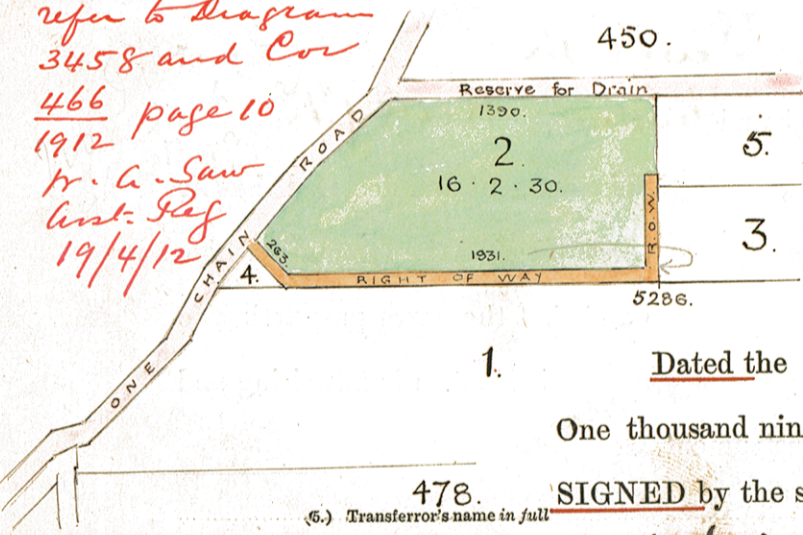

7 If within the State the execution must be attested by the Registrar of Titles, or an Assistant Registrar, or by a Justice of the Peace, Notary Public, Solicitor of the Supreme Court, Commissioner for taking Affidavits, Postmaster, Postmistress, Minister of Religion authorised to celebrate Marriages within Western Australia or any other person authorised in that behalf by the Governor in Council. If without the limits of Western Australia, either a Notary Public, or Commissioner for taking Affidavits in the Supreme Court of Western Australia, or the Mayor or other Chief Officer of any City or Municipal Corporation, or the Officer administering the Government of or a Judge of any Court of Record in any British possession, or the British Consular Officer (which expression shall include the Consul-General, Consul or Vice-Consul, and any person for the time being discharging the duties of Consul-General, Consul, or Vice-Consul) at any foreign place, or the Agent-General for Western Australia in the United Kingdom, or his Secretary.
