### NEW SCALE OF FEES

Given Executive Council approvals, DOLA advises that a new scale of fees and charges will apply from the commencement of business on Monday 7 July 2003. The new fees and charges relate to searching, document and survey registration.

The proposed amendment will increase the standard lodgement fee for land transaction documents for freehold and Crown land, from \$75.00 to \$77.00.

A new fee has been introduced for documents that contain more than 10 Certificates of Title. An additional fee of \$6.00 will be payable for each additional title in excess of 10. For example if a discharge of mortgage document contained 15 Certificates of Title, the registration fee would be \$77.00 plus 5 x \$6.00, total registration fee of \$107.00.

Applications for New Certificates of Title, the subject of a deposited plan will attract an increased fee. A new lot fee of \$6.00 applies for each lot or location, part lot or part location, or parcel of land as shown on the deposited plan. For example an Application to register a deposited plan that creates 10 new lots, would be \$77.00 for the application, plus 10 x \$6.00, total registration fee payable of \$137.00.

Conveyancers please note that this additional fee has not been extended to apply to Applications to register a Strata Plan. The fee for this application remains at \$77.00.

In summary the new standard fee charges include:

- Lodgement of a Land Transaction Document \$ 77.00
  Application to remove a Caveat (Section 138B) \$ 154.00
  Withdrawn or Rejected Document \$ 38.50
- Withdrawh of Rejected Document \$ 30.
- Production of a duplicate Certificate of Title
