PROPOSED NEW SCALE OF FEES AS OF 1 JULY 2009

Subject to the Governor's approval in Executive Council, Landgate advises that a new scale of fees will apply from 1 July 2009. The new scale of fees relate to the provision of services for document registration, plan lodgement and searching at all Landgate offices.

The proposed fee amendments will increase the base document registration fee increases from \$105.00 to \$110.00, and the deposited plan and strata/survey strata plan general lodgement fee from \$197.00 to \$204.00. The fee to obtain a copy of a Record of Certificate of Title and/or document increases from \$17.50 to \$18.00.

Other fee amendments include the following:

- The production fee for duplicate titles is increased to \$55.00 for the first Certificate of Title. The fee for producing subsequent duplicate Certificates of Title, for the same document, remains at \$6.00 for each additional duplicate Certificate of Title.
- The fee for the withdrawal of a document from registration increases to \$55.00.
- The check search fee increases to \$9.00.
- The facsimile delivery fee increases from \$2.40 to \$2.50 and now includes email services.
- The deposited plan and strata/survey-strata plan general fee increases to \$204.00. The fee for each lot, other than a lot vesting in the Crown under section 152 of the *Planning and Development Act 2005*, increases to \$56.00. This general fee now includes the former "WAPC" fee component.
- In addition, the strata plan general fee of \$204.00 is now payable upon the lodgement of a strata plan of conversion and sketch plan for merger of strata schemes. There is an additional fee of \$56.00 payable for each lot.
- The current replacement plan (additions, excisions and amendments) process has been replaced with a simplified procedure. There is now only one processing fee payable when lodging a replacement plan; the fee will be \$204.00.

In most instances Landgate's proposed fee increases are within the Western Australian Department of Treasury and Finance's 2009/10 inflation factor of 4.2%. Where applicable the fees are rounded to the nearest dollar for client convenience.
