### 1 OVERVIEW

## 1.1 Document purpose

This document describes the data contained within the comma delimited values (CSV) files as extracted from the NLR Reserves Register held at Landgate.

#### 1.2 What is a Reserve?

Reservation is the setting aside of Crown land for a specified purpose, generally a public purpose – in effect, the dedication of land to that purpose. Under section 41 of the *Land Administration Act 1997* (LAA) the Minister may set aside Crown lands by Ministerial Order in the public interest. Every such reservation has its description and designated purpose registered on a Crown Land Title (CLT) and is depicted on an authenticated map held by Landgate. Reservation action is normally initiated by the Department of Regional Development and Lands (RDL's) State Land Services Division following community or Government request, planning decisions or consequent to subdivision of land.

Reserves cover about 17.5 per cent of the total area of the State (443,393 km<sub>2</sub>).

The LAA is Western Australia's legislation dealing with the disposition of State land and it is administered by the Minister for Lands, assisted by RDL.

Part 4 of the LAA provides for the creation and administration of reserves in Crown land.

#### 1.3 Classification of reserves

The Land Act 1933 was replaced by the LAA on 30 March 1998. It provided for State reserves to be classified as Class A, B or C. There is no provision in the LAA to create new Class B reserves and there is no longer reference to Class C reserves.

Class A has the greatest degree of protection, requiring approval of Parliament to amend the reserve's purpose or area, or to cancel the reservation. The A classification is used solely to protect areas of high conservation or high community value.

Class B reserves continue, but are no longer created under the LAA. The Minister for Lands may deal with Class B reserved lands as normal reserves, provided that, should the reservation be cancelled, a special report is made to both Houses of Parliament within 14 days from the cancellation or within 14 days after the commencement of the next session.

Aside from conservation estate reserves, the Minister has general powers to deal with reserves which are not Class A or B, and retains legal and policy oversight of the use of reserves generally.

## 1.4 Crown Reserves data (CSV extract)

**The Crown Reserves CSV extract** is sourced from NLR Reserves Register and contains current and historical information pertaining to Crown Reserves and is comprised of 2 CSV files:

- 1. Reserves containing current information associated with the reserve
- 2. Reserves\_History containing historical information relating to the reserves where that information is available or exists.

These files contain information pertaining to:

- Reserve number, name and classification
- Vesting and management orders
- Approved reserve use
- Responsible agency
- Relevant searching details such as gazettal date and page, administration file/record
- Information pertaining to cancelled reserves
- Full historical information.

#### 1.5 Reserves and "Crown Grant in Trust"

Before the introduction of the *Land Administration Act 2006* (LAA) the Minister for Lands, under the *Land Act 1933*, may have issued a freehold title over a reserve, (commonly known as a **Crown Grant in Trust**) for a particular purpose or any ancillary or beneficial purpose. Crown Grants in Trust were usually issued to an organisation rather than a person and the organisation usually had a strong social or welfare reason for existence.

As a result of the implementation of the LAA, no more Crown Grants in Trust will be created under the *Land Act 1933*. The existing Crown Grants in Trust created under the *Land Act 1933* are deemed to have been granted under the LAA and any changes to them may be made in accordance with the provisions of the LAA.
